Mr. Khan extended a warm welcome to the committee members attending the Second Anti-Ragging Squad Committee Meeting for the academic year 2023-24

Agenda I-Confirmation of the minutes of meeting held on 14th October 2023

Mr. Khan inquired whether there were any points to discuss regarding the minutes circulated via email. All members unanimously confirmed that there were no matters to discuss, and they collectively affirmed the minutes.

Agenda II- To assess the effectiveness of awareness initiatives intended to educate students about the institution's strict policy against ragging.

Dr. Vinaya Vaishampayan reminded the members that the institution strictly upholds a Zero Tolerance Policy regarding Ragging .

The committee members agreed that the college has been working to spread awareness about the Anti-Ragging Policy, and there haven't been any reports of ragging on campus.

Mr. Khan requested the final year students to mentor the first and second year students as senior members, guiding them on effectively educating their peers about the institution's stringent anti-ragging policy.

Agenda III: - To present the proactive measures implemented by the institution to promote awareness regarding the repercussions of ragging and the imperative to prevent any such occurrences

Mr. khan informed members that posters displaying the message that ragging in any format will not be tolerated have been displayed in the college.

Dr. Vinaya Vaishampayan communicated to the members that the institution is extremely vigilant about the security and safety of the students on campus and that measures are in place. She informed the members of the proactive steps taken by the institution following an incident wherein fraudulent calls were being made to parents, falsely alleging their wards' involvement in kidnapping or drug-related cases. Fraudsters threatened legal action unless a ransom amount was paid. Upon learning of the situation, the authorities promptly circulated a notice to all students and parents, cautioning them about such calls. Additionally, a complaint with the nearby Matunga police station was logged regarding these extortion attempts. No further attempts by fraudsters were reported.

Dr. Vinaya shared this incident to encourage students to share any such occurrences with their peers and assured them of the institutions support in any such concern felt by the students .

Dr. Vinaya Vaishampayan extended her heartfelt appreciation to all final year students and the parent member for being a part of the Anti-Ragging squad Committee and assisting the institution.
